The dates in the referenced URENCO USA (UUSA) letter for scheduled completion of Corrective Actions for steps that will be taken to prevent further violation for Examples 1, 2, and 3 (Actions 1 and 3, as capture in CR 2010-2530 actions 7 and 2), and Example 4 (Action 1 as captured in CR 2010-2530 action 2) have been changed. The scheduled completion dates for Examples 1, 2, and 3 Actions 1 and 3 (10/31/10 and 11/5/10 respectively), have been changed to 11/15/10. The scheduled completion date for Example 4, Action 1 (11/5/10) has been changed to 11/15/10.

Due to current Cascade 1 and 2 recovery efforts the associated Commercial Grade Dedication procedure revision, appointment of a CGD Project Manager, and development of a CGD Project Plan are being postponed until 11/15/10 as stated above.
