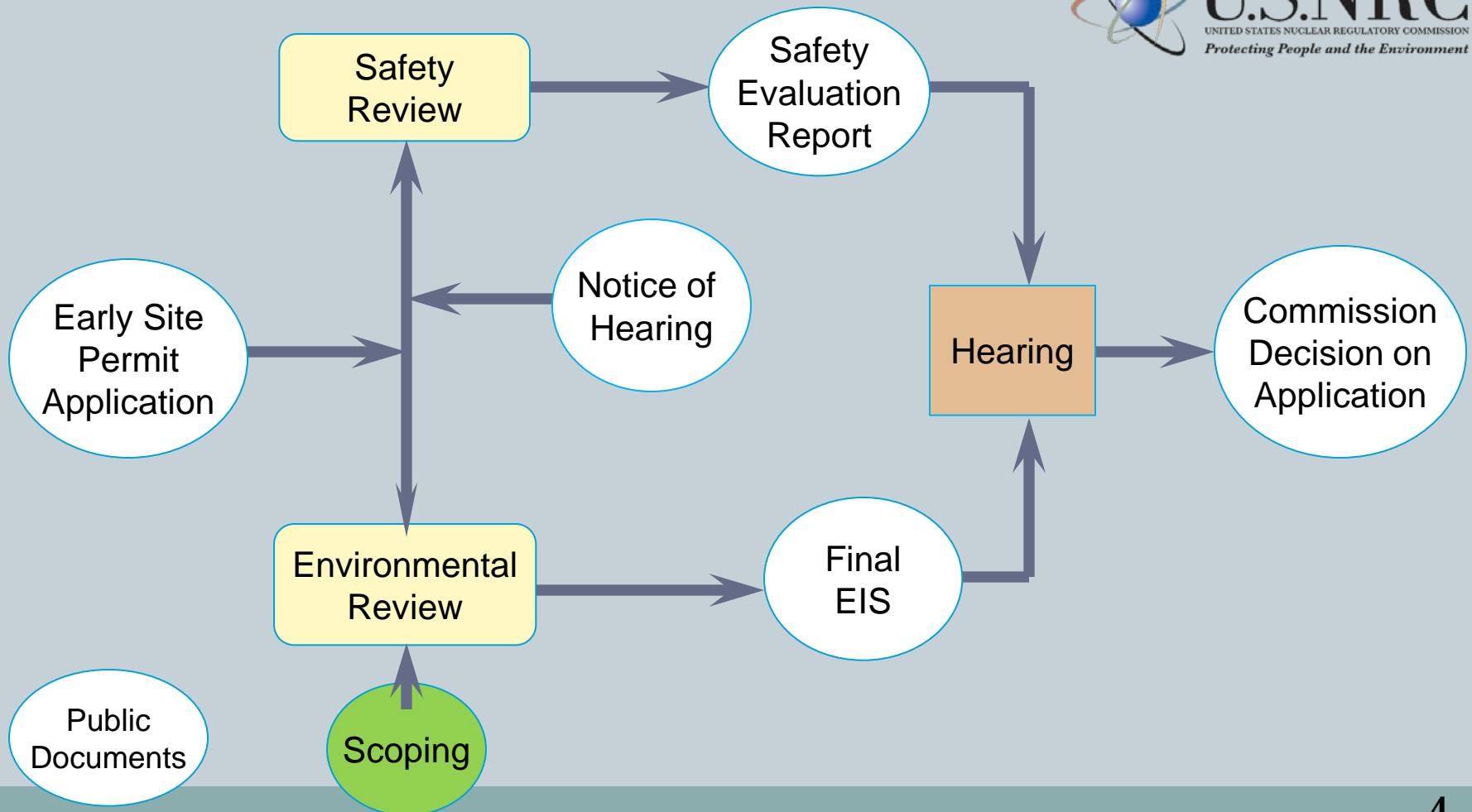
- NRC's mission:

Early Site Permit Application Review Process



Early Site Permit



- An Early Site Permit does not authorize the building and operation of new reactor units
- An Early Site Permit is issued only if a site is found to be suitable for the potential building and operation of one or more reactor units
- There will also be a formal hearing on the staff's review
- PSEG Power, LLC and PSEG Nuclear, LLC (PSEG) applied for an Early Site Permit for one or two nuclear units at the PSEG site on May 25, 2010

NRC's Environmental Review



- The National Environmental Policy Act (NEPA) requires Federal agencies to use a systematic approach to consider environmental impacts, and requires the development of an Environmental Impact Statement (EIS) for major Federal actions that may significantly affect the quality of the human environment.
- NRC considers issuing an Early Site Permit a major Federal action under NEPA.

NRC's Environmental Review



- NRC's environmental review is a NEPA review
- NRC is the lead agency for the Early Site Permit application review.
- U.S. Army Corps of Engineers, Philadelphia District is anticipated to become a cooperating agency in the preparation of the EIS.
- NRC will also address the requirements of other statutes as appropriate

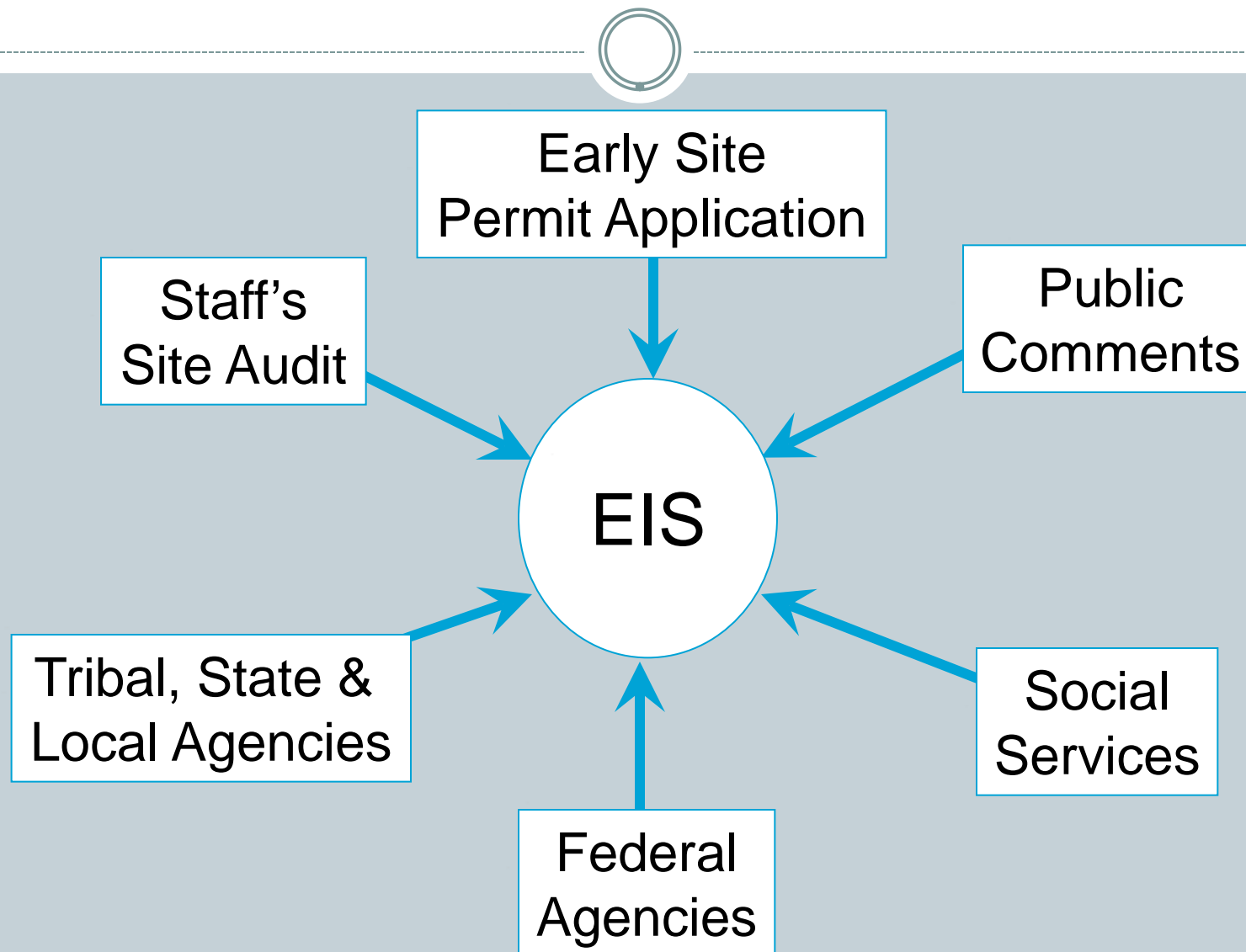


Environmental Scoping

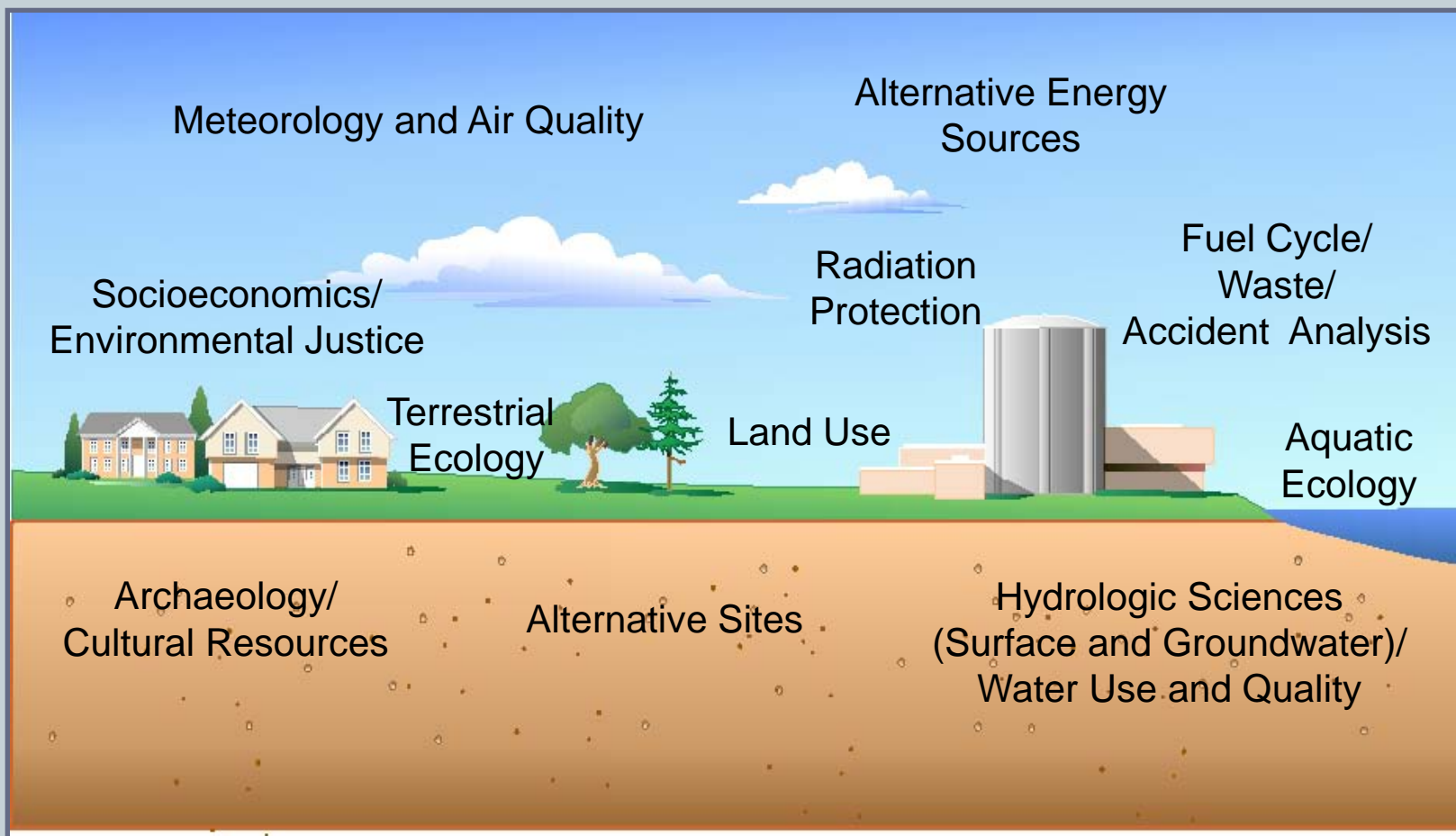


- The scoping process helps determine the significant issues to be analyzed in the environmental impact statement.
- The scoping period ends on **December 14, 2010.**
- A Scoping Summary Report will be issued following the close of the scoping period.

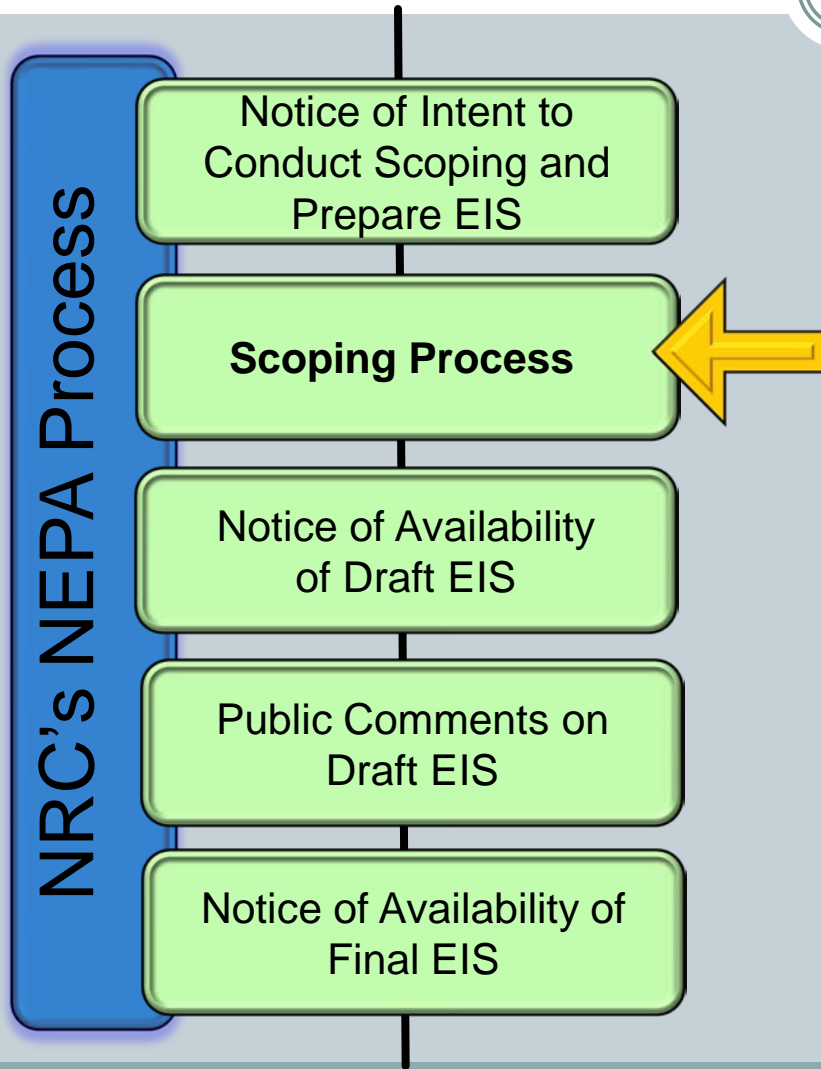

Anticipated Environmental Review Schedule



- Published *Federal Register* notice October 15, 2010.
- **Scoping period from October 15 to December 14, 2010; scoping meeting today in Carneys Point.**
- Expect to publish draft EIS in March 2012.
- There will be a 75-day comment period on the Draft EIS.
- Final EIS expected to be published in March 2013.

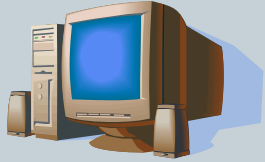
