This letter, with attachments, is being submitted as the annual surety bond update to satisfy the requirements of License Condition (LC) 27 of Source Material License No. SUA-1310 issued to Bear Creek Uranium Company. The existing surety with the NRC is sufficient to meet LC 27.

Anadarko has transferred title to the property to DOE and is now waiting on NRC for discussions on the final determination of the Long Term Surveillance Fee. The calculated surety for 2010 is \$844,477; the surety amount decreased for 2010 due to the completion of the land transfer and the elimination of corporate costs previously allocated to the land transfer.
