
LICENSE EXPIRES December 31, 2013

DESCRIPTION OF MATERIALS OR FACILITIES: (Cont'd)

DSSI is to determine the actual quantity of non-conforming waste which cannot be processed at its Boiler Industrial Furnace and must be returned after examining the material.

The license is amended to extend the expiration date from March 31, 2009 to December 31, 2013.

Applicable Condition: To proceed with this export, DSSI is required to obtain prior consent from the U.S. Environmental Protection Agency by providing an advance Notification of Intent to Export Hazardous Waste to a Foreign Source in accordance with 40 CFR § 262.53. DSSI also is responsible for complying with all other applicable Federal and State regulations.

All other terms and conditions of this export license remain unchanged.
