Janelle – The following is a list of the issues that we have been discussing and I believe you are currently looking into. We can discuss these on 9/22, or before that if you have any update information.

1. Status of any supplemental RAIs related to the 8/16/10 RAI 2.5.1-1 response (sometime in October?).
2. Estimate of staff hours for safety and environmental reviews.
3. Confirm NRC acceptability of use of an online reference portal.
4. Confirm if there is an SSAR annual update requirement (OGC).

Also, with the detailed review starting 10/1, when do you anticipate the first RAIs being ready for clarification call discussion/issuance. I believe you had indicated in June that several review branches had formulated some initial RAIs based on their acceptance reviews. So I assume that we should be getting these relatively soon.
