SUBJECT: PEACH BOTTOM ATOMIC POWER STATION, UNIT NO. 2: REQUEST FOR  
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE  
(TAC NO. ME3994)

Dear Ms. Cowan:

By letter to the Nuclear Regulatory Commission (NRC) dated August 25, 2010 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML102380310), Exelon Generation Company, LLC, (Exelon) submitted an affidavit dated August 20, 2010, executed by Mr. Russell E. Stachowski, Chief Consulting Engineer, Global Nuclear Fuel – Americas, LLC (GNF-A), requesting that the information contained in the following documents be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390(a)4:

JMD-EXN-HE0-10-056, "Response to NRC Supplemental RAI's [Requests For Additional Information] 10 through 13 for Peach Bottom Atomic Power Station Unit 2 Cycle 19 SLMCPR [Safety Limit Minimum Critical Power Ratio] submittal."

JMD-EXN-HE0-10-056, "Supporting Attachments."

A nonproprietary copy of these documents have been placed in the NRC's Public Document Room and added to the ADAMS Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GNF-A's competitors without license from GNF-A constitutes a competitive economic advantage over other companies.
- (4)b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area.
