PROTOCOL

Dear Mr. Eves:

This is to provide you written notification that the International Atomic Energy Agency (IAEA) has requested to conduct a complementary access at your facility on November 17, 2010, from 9:00 am to 3:00 pm. The U.S. Government has determined that this request is in agreement with our domestic and international law and the U.S. Nuclear Regulatory Commission (NRC) has confirmed that the request is in compliance with Part 75 Title 10 of the *Code of Federal Regulations* (10 CFR).

This letter serves as official notification of the IAEA's complementary access request and the U.S. Government's approval of the following IAEA representatives to conduct an inspection at your facility. Admission shall only be granted to the following IAEA personnel if escorted by a representative of the NRC. Additional IAEA personnel should not be allowed entrance to the facility for the purposes of assisting with the complementary access until you receive written authorization from the NRC that they are allowed to participate in the complementary access.

The IAEA representatives will present credentials as specified in 10 CFR Part 75.8(c) to confirm their identity. As required by 10 CFR Part 75.8(d), an NRC employee will be assigned to accompany the IAEA representatives at all times during the inspection. Please be aware that there will be U.S. Government personnel, in addition to NRC employees, present during the complementary access and information for those persons will be sent in another correspondence. At this time we do not intend to send clearance information for any U.S. Government personnel, and as such we expect to be processed into the facility as visitors. If you have any particular safety or health concerns that you wish to discuss with me in conjunction with the inspection, please contact me immediately.
