Thank you for putting this together. It will definitely be a help to have a starting point to facilitate drafting and finalizing an MOA.

I believe that Jenny has talked with Nathan Fleming of TRC to pass on details regarding what format the SHPO is looking for on the 2006 Arcadis Dry Willow Phase IV report. Once we receive that report from you, NRC will review that report and then forward it to the SHPO with a letter stating our determination of agreement/non-agreement with the report's conclusions. NRC plans to be working on the MOA in the meantime, but it seems from our conversations that the SHPO wants all available information in front of him before proceeding, so we can expect to move forward with the MOA once the SHPO has the 2006 report.
