The purpose of this modification is to provide incremental funding in the amount of \$22,445.00 thereby increasing the total obligations from \$540,000.00 to \$562,445.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$562,445.00 of which \$524,306.00 represents the estimated reimbursable costs, and the amount of \$38,139.00 represents the fixed fee."
