Dear Mr. Pacilio:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2010-005) on November 20, 2009, to determine whether a contract manager for SGT-Areva intentionally violated, and caused others to violate, the work hour limit rule at Three Mile Island Unit 1. Based on testimonial and documentary evidence gathered by OI during its investigation, the NRC did not substantiate that the contract manager violated, or caused others to violate, the work hour limit rule.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.
