FISCAL YEAR 2011 MASTER INSPECTION PLAN

Dear Mr. Hackmann:

In accordance with NRC Manual Chapter 2602, "Decommissioning Oversight and Inspection Program for Fuel Cycle Facilities and Materials Licensees," NRC Region III staff and management have developed a Master Inspection Plan (MIP) for the Hematite facility. The plan is projected based on your proposed schedule of decommissioning activities planned for the site for fiscal year (FY) 2011, which is from October 2010 through September 2011. The plan outlines how we intend to focus our Regional inspection resources to address significant ongoing decommissioning activities. Security and MC&A inspections will be addressed in a separate MIP since it is security related information.

Because the FY2011 MIP is based on your proposed schedule of significant decommissioning activities, the plan and the focus of NRC inspection activities may change to reflect a change in your planned decommissioning activities or your performance. In order to ensure that the MIP remains current, we request that you keep the Materials Control, ISFSI, and Decommissioning Branch staff informed of any significant changes in your proposed schedule of decommissioning activities. You will be informed of any significant changes to the Hematite FY2011 MIP.

We project that the Region will conduct inspections approximately quarterly during FY2011. These inspections will involve performance based observations of decommissioning activities, as well as NRC confirmatory surveys. The inspection procedures which we may use during our inspections are listed below. The use of specific procedures will depend on the decommissioning activities being conducted.
