Below is my responses to the comments. Let me know if you need anything else.

OGC comment 1 The regulation states "to be performed."

Response: I concur with the comment. Change "that they will perform" to "to be performed". This change was made by the QTE in order to change passive voice to active voice.

Comment 2. Exact text of regulation:

"Every applicant for a construction permit is required by the provisions of § 50.34 to include in its preliminary safety analysis report a description of the quality assurance program to be applied to the design, fabrication, construction, and testing of the structures, systems, and components of the facility."

Why isn't testing included in this description? Does this not apply to protective coatings?

Response: Concur with the comment. Change the sentence to read "Appendix B, "Quality Assurance Criteria for Nuclear Power Plants and Fuel Reprocessing Plants," to 10 CFR Part 50 establishes overall QA program requirements for the design, fabrication, construction, and testing of safety-related SSCs in nuclear power plants (NPPs)."

Comment 3. The figure is blocking this text; make sure this issue is fixed. This may have only been an issue in the Word document, since this did not happen on the PDF.

Response: Sounds like a formatting issue, do you need something from us?

Comment 4.

Response: This is a typo, change "an" to "a"
