
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$25,000.00 thereby increasing the total obligations from \$261,132.00 to \$286,132.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$286,132.00 of which \$272,988.00 represents the estimated reimbursable costs, and the amount of \$13,144.00 represents the fixed fee."
