Dear Mr. Guerrero:

On October 4, 5, & 29, 2010, Scott Wilson of this office conducted a safety and security inspection at the above address and the Central Costa Sur Power Plant, Guayanilla, Puerto Rico of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with you and Mr. Jose Serrant of your organization at the conclusion of the inspection.

Based on the results of the inspection the NRC identified security-related violation(s). Because the NRC identified the violation(s) and the violation(s) are categorized at Severity Level IV in accordance with the NRC Enforcement Policy, the violation(s) are being cited in the enclosed Notice of Violation (Notice). The Enforcement Policy is included on the NRC's website at www.nrc.gov; select **About NRC; How We Regulate; Enforcement**; then **Enforcement Policy**.

The NRC has concluded that information regarding the reason for the violation(s), the corrective actions taken and planned, and the date when full compliance was achieved is already adequately addressed on the docket as summarized in Enclosure 2. Therefore, you are not required to respond to this letter unless the description therein does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.

The Enclosures contain Sensitive Unclassified Non-Safeguards Information. Upon separation, this cover letter is decontrolled.
