RESPONDENTS' STATUS REPORT

In response to the Court's Order of July 28, 2010, directing that the parties file a status report by August 27, 2010, and every thirty days thereafter, ¹/₂ Federal Respondents submit the following report:

The Nuclear Regulatory Commission continues to have under active deliberation the 23 briefs filed on or before July 19, 2010, by 13 participants in the licensing proceeding addressing whether the Commission should review, and reverse or uphold, the Atomic Safety and Licensing Board's June 29, 2010, order

The July 28, 2010, Order granted Respondents' motion to vacate the briefing and oral argument schedule and to hold the cases in abeyance, and ordered "these cases be held in abeyance pending further proceedings before the respondent agency consistent with the motion." *Id.* The Court ordered the parties to file status reports at 30-day intervals and to file motions to govern future proceedings within 10 days from the Commission's "final decision in its pending review of the Licensing Board's June 29, 2010 decision." *Id.*

denying the Department of Energy's motion to withdraw with prejudice its application to construct a high-level waste repository at Yucca Mountain, Nevada.

In four letters from individual Commissioners, dated November 4 or November 5, 2010, that responded to a November 1, 2010, inquiry from Senator James Inhofe, individual Commissioners stated: Commissioner Svinicki filed her vote with Secretary of the Commission on the matter on August 25, 2010; Commissioner Ostendorff entered his vote on August 26, 2010; Commissioner Magwood registered his vote on September 15, 2010; Chairman Jaczko first voted on August 25, 2010 and subsequently withdrew his vote and continued active consultation with colleagues before re-voting on October 29, 2010. The letters from these Commissioners did not disclose how they voted. Copies of the four letters are attached.

Chairman Jaczko's letter indicated that "initial votes on adjudicatory matters are essentially an exchange of preliminary views for discussion and deliberation among the Commissioners." He added that "[n]ot until deliberations are complete does the Commission vote on a final Order ..., which is publicly affirmed, and is the public record of the Commission's decision." The Commission has not yet issued a final decision in response to the briefs in the Yucca Mountain proceeding.


