This letter serves as a request to amend the current license to reflect the following changes:

1. The legal name has changed from Severstal North America, Inc to Severstal Dearborn, Inc. The address has changed from 3001 Miller Rd. Dearborn, MI 48192 to 4001 Miller Road P.O. Box 1699 Dearborn, MI 48121. The federal tax identification number has not changed.
2. The Radiation Safety Officer will change from Mr. Ron Sayer to myself, Mr. Jason M. Ruehl, mobile telephone number (313) 623-5209 and office telephone number (313) 322-4910. Included in this amendment request is a copy of my Radiation Safety Officer Certificate as proof of required training, described in Criteria in section 8.7.1 of NUREG-1556, Volume 4, dated October 1996.

Appropriate changes in operating and emergency procedures for notification purposes will be developed and communicated to appropriate personnel. The Radiation Safety manual will reflect these changes.

There are no changes in the use, possession, location, or storage of the licensed material, and licensed activities will continue at this facility.

Currently there are no known open corrective or enforcement actions pending for this US-NRC Radioactive Material License #21-26151-01 (Amendment 6), Docket 030-31548.

The current license parameters regarding constraints, conditions, requirements, representations and commitments will be abided by. The current Radiation Protection Manual will be utilized until it can be updated reflecting the RSO change and operating/emergency procedures change in regard to the RSO change.

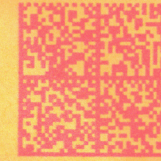
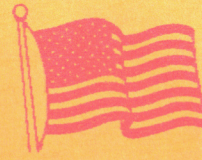
