ME4298, ME4299, ME4301, ME4302, ME4303, ME4304, ME4305, ME4306, ME4307, ME4308, ME4309, ME 4310, ME4311, ME4312, ME4313, AND ME4314)

Dear Mr. Pacilio:

By letter to the Nuclear Regulatory Commission (NRC) dated July 23, 2010 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML102070168 (non-public)), Exelon Generation Company, LLC submitted its Cyber Security Plan, which superseded in its entirety the Cyber Security Plan dated November 23, 2009 (ADAMS Accession No. ML093280234 (non-public)).

The June 23, 2010, Cyber Security Plan is based on Nuclear Energy Institute (NEI) 08-09, Revision 6 which the the NRC staff stated, in its letter dated May 5, 2010 (ADAMS Accession No. ML101190371), would be acceptable for use by licensees to comply with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) 73.54 with the exception of the definition of "cyber attack."

The NRC staff is reviewing your submittal and has determined that additional information is required to complete the review. The specific information requested is addressed in the enclosure to this letter. During a discussion with Mr. Douglas Walker of your staff on November 29, 2010, it was agreed that you would provide a response 30 days from the date of this letter.

The NRC staff considers that timely responses to requests for additional information help ensure sufficient time is available for staff review and contribute toward the NRC's goal of M. Pacilio

In reviewing the Exelon Generation Company's (Exelon's) submittal dated July 23, 2010, for the subject plants, the Nuclear Regulatory Commission staff has determined that the following information is needed in order to complete its review:

Cyber Security Plan Section 4: Establishing, Implementing, and Maintaining the Cyber Security Program Title: Defense-in-Depth Protective Strategies – Critical Digital Asset (CDA) Isolation Strategies.

Section 73.54(c)(2) to Title 10 to the *Code of Federal Regulations* requires the licensee to apply and maintain defense-in-depth protective strategies to ensure the capability to detect, respond to, and recover from cyber attacks. Section 4.3, "Defense-in-Depth Protective Strategies," of the Exelon Generation Company, LLC (Braidwood, Byron, Clinton, Dresden, LaSalle, Limerick, Oyster Creek, Peach Bottom, Quad Cities, and Three Mile Island) Cyber Security Plan states (1) when referring to protections which isolate or secure safety-related CDAs within Level 4 and security CDAs within cyber security defensive levels 4 and 3, that these devices may be secured via "one or more deterministic devices (i.e., data diodes, air gaps) that isolate CDAs in level 4, or one or more non-deterministic network isolation devices."

Clarify if any of the non-deterministic devices for the safety-related CDAs and security CDAs are in parallel (i.e., connecting the same network segments) with the deterministic devices. Clarify if any of the non-deterministic devices for the safety-related CDAs and security CDAs are in parallel (i.e., connecting the same network segments) with the deterministic devices. If any safety-related and security devices are in parallel address why this configuration would not negate the protection afforded by the deterministic devices.
