Subject: Standard Practice Procedures Plan for a Non-Possessing Facility Clearance

AREVA Enrichment Services LLC (AES) hereby submits a Standard Practice Procedures Plan (SPPP) for a Non-Possessing Facility Clearance (Enclosure 1) for AES, doing business at 4800 Hampden Lane, Suite 1100, Bethesda, MD 20814. AES requests that the NRC issue a Non-Possessing Facility Clearance to AES for the purpose of reviewing the joint NRC/DOE Guidance for the Protection of Classified Information. Such review would take place at a time and NRC location determined by the NRC.

AES has previously submitted an SPPP for the Eagle Rock Enrichment Facility (EREF) (Ref. 1) to be located in Bonneville County, Idaho. This SPPP included the required Owners, Officers, Directors, and Executive Personnel, Form 405f and Certificate Pertaining to Foreign Interests, Form SF-328. The NRC has reviewed this SPPP and found it satisfies the requirements of 10 CFR Part 95 (Ref. 2). Also provided in Enclosure 2 is the designated AES facility security officer who will review the joint NRC/DOE Guidance for the Protection of Classified Information.

Enclosures 1 and 2 provide security-related sensitive unclassified non-safeguards information (SUNSI) that should be withheld from public disclosure in accordance with 10 CFR 2.390.

In order to support the EREF project schedule, AES requests NRC review and approval of the Non-Possessing Facility Clearance by January 1, 2011. AES will support this effort by promptly responding to any NRC questions or comments.
