PROPRIETARY INFORMATION RELATED TO A LICENSE AMENDMENT REQUEST UNDER REVIEW TO REVISE THE TECHNICAL SPECIFICATIONS FOR THE SPENT FUEL POOL K-INFINITY VALUE (TAC NOS. MD9154 AND

MD9155)

On January 7, 2010, a Category 1 public meeting was held between members of the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of Exelon Generation Company, LLC (Exelon) at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The purpose of the meeting was to discuss the supplement provided by Exelon Nuclear on December 18, 2009, regarding a License Amendment Request to revise the Technical Specifications related to the Spent Fuel Pool K-infinity value for Peach Bottom Atomic Power Station (Agencywide Documents Access and Management System (ADAMS) Accession No. ML093521435).

Proprietary information associated with the amendment request was discussed during the closed portion of the meeting. Exelon representatives addressed questions from the NRC staff regarding the analytical and testing methods used to determine the Boraflex degradation rates reported in the December 18, 2009, submittal. Questions regarding the analytical methodology used for the spent fuel pool criticality analysis were also discussed. The meeting concluded with an open portion for public questions and comment, however, no members of the public attended the meeting.

On March 4, 2010, the NRC staff issued a Request for Additional Information (RAI) letter to Exelon (ADAMS Accession No. ML100610290). This letter contains non-proprietary RAI questions based in part on the discussions held during the January 7, 2010, meeting.

No regulatory decisions were made during the meeting. A list of the meeting attendees is provided in the Enclosure.
