**APPLICANT POWERTECH (USA) URANIUM CORPORATION'S MONTHLY  
UPDATE TO INITIAL MANDATORY DISCLOSURES**

Pursuant to 10 C.F.R. § 2.336(a) & (b) and the September 23, 2010, oral determination of the Atomic Safety and Licensing Board (Licensing Board), Powertech (USA) Uranium Corporation (Powertech) hereby submits its December, 2010 monthly update to its mandatory disclosures for this proceeding:

**1. Potential Testifying Witnesses**

On September 13, 2010 and pursuant to 10 C.F.R. § 2.336(a)(1), Powertech submitted its initial mandatory disclosures, including a list of organizations (e.g., consultants, etc.) from which testimony may be solicited during the hearing process. Powertech expressly noted in its submission that

“its proposed potential witness list includes the name of one person from each company or organization that potentially may be called upon to offer expert witness testimony in this proceeding. In the future, the identified person may designate a member of his/her company or organization to offer expert testimony based on his/her specific area of expertise.”
