In its Initial Scheduling Order dated May 19, 2010, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff") to submit monthly a "short report specifying its best estimates of the dates when it expects to issue the draft and final version of the EIS, and the dates it expects to issue the SER, including any 'advance' SER, SER with open items, and its final SER."
