2. Physical Description

Thirty Six (36) NT-IV shipping containers, each of which contains two (2) fuel assemblies for a total of Seventy Two (72) fuel assemblies. The shipment contains nominally 12,236 KgU and 465 Kg²³⁵U at an average enrichment of approximately 3.76 wt% U²³⁵. The NT-IV's are loaded onto nine flat rack containers.

3. Transport Route

The shipment will depart from Oakland, CA via the vessel "Ever Reward" going to Tokyo, Japan. Upon arrival at Tokyo, Chubu Electric Power Co., or its agent, will take physical custody of the shipment as arranged prior to shipment.

4. Schedule

The shipment is scheduled to depart Richland on August 30, 2010 and to depart Oakland, CA on September 2, 2010 and is expected to arrive at Tokyo on September 14, 2010. The shipment will depart Tokyo on September 14, 2009 and arrive at Chubu Electric Power Co. Inc., Hamaoka Unit 3 on September 14, 2010.

5. Assurance

The shipment will be protected during transport in accordance with IAEA Information Circular 225, "Physical Protection of Nuclear Materials".
