The DEIS and the Corps's evaluation of the proposed project were noticed by the U.S. Army Corps of Engineers (Corps) by public notice dated August 13, 2010; and by the Nuclear Regulatory Commission's (NRC) by publication of a notice in the Federal Register on August 13, 2010. A 75-day comment period was provided to allow interested parties to provide comments in regard to the issuance of the DEIS and the Corps's public notice. The comment period ended on October 27, 2010.
