The purpose of this modification is to provide incremental funding in the amount of \$6,000. Total obligations are hereby increased by \$6,000 from \$110,000 to \$116,000. Accordingly, paragraph (b) of section A.2 entitled "Consideration and Obligation - Labor Hour Orders" is revised to read as follows:

(b) The amount currently obligated by the government with respect to this contract is \$116,000. The contractor shall not exceed this obligated amount at any time."
