The purpose of this modification is to exercise Option Period Two and provide incremental funding in the amount of \$231,311.19, thereby increasing the ceiling and obligated amount from \$430,102.44 to \$661,413.63:

In accordance with Section A.7 52-217.9, OPTION TO EXTEND THE TERM OF THE CONTRACT, Option Period 1 under the subject contract is hereby exercised by the Government. As a result, the period of performance of the subject contract is extended to December 31, 2011.

Accordingly, the following section of the contract is hereby modified:

Section A.3 CONSIDERATION AND OBLIGATION, the first sentence of paragraphs (a) and (b) are deleted entirely and the following is substituted in-lieu thereof:

"(a) The firm fixed price of this contract (ceiling) is \$661,413.63."

"(b) The amount presently obligated with respect to this delivery order is \$661,413.63."
