Gibson (UniStar Nuclear Energy) to U.S. Nuclear Regulatory Commission (NRC), "Response to Request for Additional Information for the Calvert Cliffs Nuclear Power Plant, Unit 3, RAI No. 57, Question 12.01-1, Radiation Protection – ALARA Program", UN#09-146, dated March 9, 2009 (ML090700540)

The purposes of this letter are to endorse responses to Request for Additional Information (RAI) RAI No. 57 Question 12.01-1 by the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3, the Reference Combined License Application (RCOLA), identify that changes will be made to the BBNPP COLA as a result of this endorsement, and provide supplemental information related to the CCNPP Unit 3 RAI No. 57 responses.

In CCNPP Unit 3 RAI No. 57, Question 12.01-1, a response was provided by CCNPP Unit 3 (Reference 1). This response is also applicable to the BBNPP COLA and is endorsed by PPL Bell Bend, LLC (PPL), including the following supplemental information. In the response for CCNPP Unit 3 RAI Question 12.01-1, the RAI response indicates that the CCNPP Unit 3 COLA will be updated to incorporate NEI 07-08 if the NRC accepts or otherwise endorses the NEI document. The supplemental information provided in this letter is that NEI 07-08 has been approved by the NRC and is now identified as NEI 07-08A, Revision 0, and the BBNPP COLA will be revised to include the approved NEI document in FSAR Chapter 12.

The only new regulatory commitment in this letter is to update the BBNPP COLA at a future date.


