SUBJECT: SUMMARY OF THE DECEMBER 2, 2010, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On December 2, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff presented and discussed preliminary comments on FAQ 08-0054, which deals with compliance with NFPA 805 Chapter 4. Licensees and the NRC staff discussed the comments, and the staff stated that they would be providing additional comments in the near future. The licensees stated that they would incorporate the comments in a new revision of this FAQ once all of the NRC comments were received.

NRC staff presented an updated schedule for the review of the Oconee pilot plant's license amendment requests.

Participants agreed that the next FAQ meeting would take place on December 16, 2010, via teleconferencing. A future meeting was scheduled, as a teleconference, for January 20, 2011.
