We are in receipt of your most recent updates to your requesting renewal application. We have reviewed your submitted materials and find that we are unable to continue this action until we have received information regarding the following:

Please submit a signed form indicating the actual date of signature.
 - (2) The applicant's name & address given on each of your 2 submitted Form 313s is inconsistent with the name & address listed in our records. Please verify, and use the correct name & address when resubmitting the application. Based on our conversations with you, it is our understanding that the correct name is Terra Haute Heart Center, Inc., as listed at the top of this page.
 - (3) In the original Application's Table of Contents as well as in Items 8, 10 & 11, references were made to NUREG 1556, Volume 9, Rev. 1. We have noted that the updated references listed in the Table of Contents as well as in Items 8 & 10 have been corrected to reference the most current revision - NUREG 1556, Volume 9, Rev. 2. However, the reference cited in Item 11 still cites NUREG 1556, Volume 9, Rev. 1. Please update the references listed in Item 11 to NUREG 1556, Volume 9, Rev. 2.
 - (4) We have requested that you resubmit the entire application, via facsimile, to (630) 515-1078. Please reference the Control No. 573307, as listed at the top of this memo. We expect to hear from you on or before Wednesday, November 17, 2010.
