I am writing you to inquire about the uranium enrichment plant in Metropolis, Illinois. As you know a labor dispute between the plant owner, Honeywell, and the United Steelworkers of America (USW), is approaching its fifth month. As a result of the dispute, Honeywell has staffed the plant with temporary workers.

Recently, a Nuclear Regulatory Commission (NRC) report identified safety lapses at the plant. Specifically, are you aware of any safety issues caused by a lack of experience and training on the part of the temporary workers? If so, what steps has the NRC taken to address staff deficiencies which may lead to safety lapses at the Honeywell Metropolis plant?

I am very concerned about any safety concerns at the Metropolis uranium facility, however minor they may be. I would appreciate a written response to this letter within ten business days.
