The purpose of this E-mail is to notify you that on July 30, 2010, Gilbane Building Company ("Gilbane") purchased 100% of the capital stock of Innovative Technical Solutions, Inc. ("ITSI"). ITSI holds the NRC license 04-29353-01 with the NRC.

The acquisition of ITSI stock by Gilbane has not changed ITSI's operations, personnel resources, systems or other capability required for performance under this license. Our management remains the same at the highest corporate levels, and the same personnel will be working on ITSI's licensed projects in the future.

We believe that no change in the license is required. However, the NRC provided guidance for ITSI to complete the attached form, and then the NRC will determine if there is a need to revise our license.

(includes Change of Name)

10 CFR 30.34(b) states that "no license issued or granted pursuant to the regulations...nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall...find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing. Although not specifically addressed by 10 CFR 30.34, licensees undergoing a name change may also be affected by this regulation.

Control over licensed activities can be construed as the authority to decide when and how a license (licensed material and/or activities) will be used. A change of ownership may be an example of a change of control. The central issue is whether the authority over the license has changed. In all cases, determining whether a change of control has taken place or whether a change is in name only is the Commission's responsibility.

Licensees must notify the Commission when they are undergoing a possible change of control and/or a change of name. While this notification is not required within a certain time frame, NRC needs adequate time to review the submittal to ensure that the transfer is in accordance with the regulations.



Supplemental Information to 1A Response.

The purpose of this E-mail is to notify you that on July 30, 2010, Gilbane Building Company (“Gilbane”) purchased 100% of the capital stock of Innovative Technical Solutions, Inc. (“ITSI”). ITSI holds the NRC license 04-29353-01 with the NRC.

It is our understanding, pursuant to 10 CFR 30.34 (b), notification of any changes to the ownership must be considered; however, no change in authority has occurred. In contrast, the FAR 42.1204 (relative to federal contracts) provides that a novation is not required when a stock purchase is contemplated and when “there is no legal change in the contracting party, and when the contracting party remains in control of the assets and is the party performing the contract.” FAR 42.1204(b).

ITSI will retain control of assets required for License performance and will remain the party responsible for performance of the license. The NRC’s and ITSI’s rights and obligations under the License are unaffected by the stock purchase. Additionally, no change of name is associated with the stock purchase; however, ITSI plans to recognize its affiliation with Gilbane through a minor revision to the company logo.

We are pleased to assure you that ITSI’s management team is unchanged as a result of this stock purchase; Devendra Shukla will continue as CEO of ITSI, and all other senior executives and managers will remain in their key positions in the company including ITSI’s Radiation Safety Officer James (Jay) Pride and other individual named in the license. ITSI will continue to execute the work under all license conditions and the same license-named personnel, resources, and approved systems per the license.

Our management remains the same at the highest corporate levels, and the same personnel will be working on ITSI’s licensed projects in the future.
