### South Texas Project Units 1 and 2 Letter to NRC Commissioners Regarding GSI-191 Status

Dear Chairman Jaczko,

The purpose of this letter is to inform the Commission that STP Nuclear Operating Company (STPNOC) intends to pursue a risk informed approach to close GSI-191 for STP Units 1 and 2. The intent of STPNOC's risk informed approach will be to develop comprehensive and robust probabilistic models of phenomena related to pipe breaks, including the associated uncertainties. STPNOC plans to use this approach to aid in closing GSI-191 for STP; however, STPNOC also proposes this effort as a pilot for an approach that is transferrable to other licensees. STPNOC will use existing risk informed regulatory processes to pursue approval of this risk informed approach.

STPNOC has drafted a project plan to develop, implement, and achieve regulatory approval of this risk informed approach. A team of experts from industry and academia is being assembled with a project start date in the first quarter of 2011.

We intend to communicate the details of this risk informed approach with the NRC Staff in early 2011 and then continue to communicate project results and status throughout 2011. The project plan includes a milestone to discuss the initial results with the NRC Staff near the end of 2011. Following these discussions with the NRC, the scope and milestones for 2012 and 2013 will be finalized. A key success factor of this pilot project is the involvement of NRC Staff knowledgeable in risk applications and the associated technical areas

We look forward to working with the staff with support of the Commission.
