The purpose of this letter is to provide schedule information for the request for additional information (RAI) Question 10.04.05-2 identified in NRC correspondence to PPL Bell Bend, LLC (PPL) (Reference 1). This RAI addresses the Circulating Water System as discussed in Chapter 10 of the Final Safety Analysis Report (FSAR) and submitted in Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA).

Reference 2 identified that RAI No. 95 responses would be impacted by the on-going relocation of the plant footprint within the BBNPP site and that the responses would be submitted concurrently with the revised FSAR Chapter 10 text. Since that submittal (Reference 2), it has been determined that the time necessary to complete the analysis and response for Question 10.04.05-2 will extend beyond the targeted submittal date for the FSAR Chapter 10 supplement related to the plant footprint relocation. The response for Question 10.04.05-2 will be submitted on or before March 11, 2011.

The only new regulatory commitment in this letter is to submit the RAI No. 95 Question 10.04.05-2 response on or before March 11, 2011.
