On behalf of the Council of State Governments (CSG) Midwestern Radioactive Materials Transportation Committee, we are writing in response to the U.S. Nuclear Regulatory Commission's (NRC) notice of availability of draft guidance for public comment (75 FR 67636, published November 3, 2010). The committee consists of gubernatorial and legislative appointees from the 12 Midwestern states: Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin. We respectfully request a 90-day extension of the deadline for commenting on the draft guidance document (NUREG-0561, Revision 2).

We requested the extension so that we can conduct a thorough evaluation of the new provisions and their potential impact on state agencies.
