SUMMARY

This refers to your letter dated September 24, 2010 (with attachments), and the exchange of voices messages between John Thornton and Michael Herr on December 8, 2010, and December 9, 2010.

In your dated September 24, 2010 (with attachments) you requested to have Auburn Hills, Michigan facility removed from your NRC Materials License. However, you did not include a copy of the license for the facility that you transferred one of your Auburn Hills gauges to for disposition. Due to insufficient information to complete our review in accordance with 10 CFR 30.36 (j)(1), we are unable to approve your request to remove the Auburn Hills, Michigan facility from your NRC Material Licenses. **Please respond by providing a copy of the State of Pennsylvania License No. PA-0281A for the facility that the Troxler Model 3440 (Serial No. 24497) was transferred to for disposition.**

Address your written response to my attention at the above address and please be sure to reference Control No. 573631 to facilitate proper handling in our office. As a reminder, please provide the information requested in writing, accompanied by a transmittal letter that is appropriately dated and signed by a senior management official.


