14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to exercise option period 3, which extends the period of performance through 12/6/11 and increases the order ceiling by \$11,200 from \$31,700 to \$42,900. The modification does not obligate any funds. Accordingly, the first sentence of paragraph (A) of section A.6 entitled "Consideration and Obligation" is modified to read as follows:
"(a) The total estimate amount of this BPA (Ceiling) for the products/services ordered, delivered and accepted under this BPA is \$42,900."
Also, this first sentence of section A.11 entitled "Duration of the BPA" is modified to read as follows"
"This BPA shall commence on December 5, 2007 and will expire on December 6, 2011."
All other terms and conditions remain the same.
Total Obligated Amount: \$5,000 (unchanged); Total BPA Ceiling: \$42,900 (changed); PoP: 12/5/2007 - 12/6/2011 (changed).
