This modification confirms verbal authorization given on December 16, 2010 to continue the efforts under this Task Order No.05 with an increase in obligations of \$20,000.00.

The purpose of this modification is to provide incremenatal funding in the amount of \$40,000.00. Accordingly this contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$778,405.00 of which \$631,927 represents the estimated reimbursable costs, and the amount of \$53,401 represents the fixed fee."

All other terms and conditions shall remain the same, including the contract ceiling of \$844,184.00
