The U.S. Nuclear Regulatory Commission (NRC or the staff) and representatives of Energy Northwest, held telephone conference calls on January 5, 2011, to discuss the following requests for additional information (RAIs) concerning the Columbia Generating Station (CGS) license renewal application (LRA).

Discussion: The staff has revised the RAI numbers, "Follow-up to RAIs B.2.26-5 and B.2.42-3" for the RAIs sent out in a letter dated December 27, 2010 (ML103550603). The revised numbers are "RAIs B.2.26-6 and B.2.42-4." The applicant understands the renumbering of RAIs and will respond to the updated RAIs with the revised tracking numbers.

The staff discussed their concerns for other susceptible systems not checked for cavitation erosion. The staff also discussed methodologies to manage loss of material due to cavitation erosion. The applicant understands the request and will provide a response to the RAIs.
