Mr. Barry:

I am not an attorney and I cannot provide you with a legal opinion but what I am citing below is part of the regulation. I hope what I have provided you helps answer your question. If you need anything else, please feel free to contact me.

10 C.F.R. § 2.314 (b) states that “A partnership, corporation, or unincorporated association may be represented by a duly authorized member or officer, or by an attorney-at-law.” (emphasis added) Anyone appearing in a representative capacity must file a “notice of appearance” as described in § 2.314(b). For a non-attorney representative, that notice must, among other things, state “the basis of his or her authority to act on behalf of the party.” (emphasis added)

In short, an organization may be represented by someone other than an attorney, as long as that representative’s notice of appearance provides the information specified in § 2.314(b) confirming that the person is authorized to act on the organization’s behalf.
