SUBJECT: REINITIATION OF SECTION 106 PROCESS FOR THE NORTH ANNA POWER  
STATION UNIT 3 SUPPLEMENTAL ENVIRONMENTAL IMPACT STATEMENT

Dear Chief Hicks:

The U.S. Nuclear Regulatory Commission (NRC) staff is reviewing a June 2010, revision to the combined license (COL) application submitted in November 2007, by Dominion Virginia Power (Dominion) to construct and operate a new nuclear power plant, Unit 3 at its North Anna Power Station (NAPS) site in Louisa County, Virginia. The revised application reflects Dominion's decision to change the type of reactor design referenced in their original application from the Economic Simplified Boiling Water Reactor (ESBWR) design to the US Advanced Pressurized Water Reactor (US-APWR) design. This change in the referenced reactor technology occurred after the NRC staff completed its environmental review resulting in the publication of NUREG-1917, "Supplemental Environmental Impact Statement for the Combined License (COL) for North Anna Power Station Unit 3," in February 2010. As part of the staff's review of this revision to Dominion's COL application, the NRC is preparing a supplemental environmental impact statement (SEIS) to NUREG-1917, "Supplemental Environmental Impact Statement for the Combined License (COL) for North Anna Power Station Unit 3." NUREG-1917 supplemented the final environmental impact statement developed for Dominion Nuclear North Anna, LLC Early Site Permit (ESP). NUREG-1811, "Environmental Impact Statement for an Early Site Permit at the North Anna ESP Site," was published in December 2006.

This is to inform you that the NRC staff is reinitiating consultation under Section 106 of the National Historic Preservation Act (NHPA) of 1966, as amended with the Advisory Council of Historic Preservation (ACHP) and the Virginia Department of Historic Resources (VDHR) regarding the revised application for a COL for Unit 3 at NAPS. In a letter to your office dated April 4, 2008, the NRC indicated that it would use the procedures in Title 36 *Code of Federal Regulations* (CFR) 800.8(c) to comply with the obligations imposed under Section 106 of the NHPA in lieu of the procedures set forth in 36 CFR 800.3 through 800.6. Consequently, the NRC staff will be contacting parties identified previously to inform them of our plans to reinitiate consultation as a result of the revisions to the proposed project.

Additionally, the NRC staff requests your participation in the scoping process to help identify any potential effects that the change in the reactor technology might have on our previous determination of impacts to historic properties on the NAPS site. Also, to complete consultation under 36 CFR 800.8(c), the NRC staff will forward the draft supplement to consulting parties, including your office, for review and comment and will address the comments in the final supplement. The draft supplement may include any changes to our previous determination of the impacts, if warranted.
