

The purpose of this proposed modification is to:

1. Correct typographical errors on pages 2-3 of Modification No. 3. (Refer to **ATTACHMENT** to this modification, which highlights corrections and replaces pages 2 - 3 of Modification No. 3 entirely.)
2. Exercise 3 month Option for Recurring Services under Option Year 1, thereby increasing the ceiling of the contract by \$16,950, from \$665,650 to \$682,600.
3. Provide funding in the amount of \$16,950.00, thereby increasing the obligated amount of the contract from \$654,100 to \$671,050.

As a result of the above,

- 1) The total Firm Fixed Price (FFP) of this contract increases by \$16,950 from \$665,650 to \$682,600.
- 2) Option Year 1 ceiling increases by \$16, 950, from \$85,350 to \$102,300.

The purpose of this proposed modification is to:

1. Separate Recurring Services for **Option Year 1** from 12 months to 9 months (04/02/2010 – 01/02/2011) with a 3 month Option (01/03/2011 – 04/02/2011) to allow MediaSpan to provide the NRC with additional search indexing. There is no change to the Recurring Software Services for the 12 month period.
2. Reduce scope for Recurring Services for the last 3 months (New Option) under **Option Year 1** and all 12 months of **Option Year 2**, since the NRC will only utilize the Enterprise-level Google® Search Appliance, but will not use MediaSpan's COTS product to manage NRC's public web site content.
3. Revise **Fixed Price Option 7** for additional search indexing to clarify that this item is based on 20 units of 250,000 documents each at a price of \$7,500 per unit = \$150,000, as originally proposed by MediaSpan. This revision will allow the NRC to exercise from 1 - 20 units as separately priced line items. Via conference call on 9/22/2010, MediaSpan hereby confirms that the NRC provided a notification of its intent to exercise 4 units x \$7,500/unit = \$30,000.

As a result of the above,

- 1) The total Firm Fixed Price (FFP) of this contract increases by **\$11,550**, from \$654,100 to **\$665,650**
Option Year 1 (already exercised) increases by **\$11,550**, from \$73,800 to **\$85,350**
 - Option Year 2 decreases by **\$6,000**, from \$73,800 to **\$67,800**
 - The Total Value of the Contract, should all options be exercised, decreases by **\$7,500**, from \$877,900 to **\$870,400**
