Dear Mr. Torres:


Enclosed are responses to your e-mail of October 25, 2010, including a larger scale drawing of the storage facility.

As you are aware at this time the U. S. Department of Energy has decided not to contract for the private storage of the depleted uranium oxide. Therefore Armor Industries will not be moving forward on the storage of this particular material. However, Armor Industries will be pursuing similar contracts for storage in the future.

Because of this change in plans, Armor Industries is requesting that your review of our application for a radioactive materials license be placed on hold. It is our understanding that this hold will be effective until November 20, 2011, and that at any time between now and then Armor Industries may request that the review be reactivated and that the monies so far paid to the U. S. Nuclear Regulatory Commission will be applied to the license fee decided upon at that time.
