Dear Dr. Harlan:

Enclosed is Amendment No. 05 to your NRC Material License No. 21-32168-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In your correspondence to us dated November 17, 2010, you indicated that you wished to release for unrestricted use an "old" nuclear medicine suite, located at 14700 Lakeshore Drive, Charlevoix, Michigan. The NRC staff has reviewed your final status surveys for the "old" nuclear medicine suite. Based on its review, the staff has concluded that the referenced "old" nuclear medicine suite may be released for unrestricted use.

In addition to your requested changes and in accordance with current NRC policy, we have added a condition limiting possession of licensed materials to quantities below the minimum limit specified in 10 CFR 30.35(d), for establishing decommissioning financial assurance.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
