The Nebraska Office of Radiological Health has reviewed the proposed rule and offers the following comments:

We are in agreement with the Organization of Agreement States, the Texas Radiation Control Program and others that commented that the proposed regulations are overly burdensome. Regulations should be issued that implement the wording of the current orders. Until a threat to this material is more sharply defined or change in the threat occurs, the proposed regulations are unjustified.

Additionally, the regulatory activities that were formerly carried out under the NRC's Common Defense and Security (large irradiator and M&D inspections) that are proposed to be shifted to the Agreement States under Health and Safety should be accompanied with funds necessary to pay the direct costs incurred by the State governments in implementing the regulation.

Since few changes were made by NRC staff as a result of Agreement States comments on the predecisional draft of the proposed regulations, the NRC should also make available to the Director of the Office of Management and Budget any written communications submitted to the agency by State officials, including state's comments on the pre-decisional draft of Part 37.
