

Accordingly, the following change is hereby made:

1. Section B.3., CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), Paragraph (c) is hereby deleted in its entirety and replaced with the following:

(c) The amount currently obligated by the Government with respect to this contract is **\$462,000**, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee.
