**PILGRIM WATCH REPLY TO ENTERGY'S REQUEST TO
CHANGE THE HEARING DATE**

Entergy requested a change in the schedule for the hearing and potential oral argument on new pending contentions from March 2 and 3 to March 9 and 10.

Entergy made note that I am scheduled to be in Cuba from March 12 to March 20 and I therefore request that the time from March 11 to March 20 be considered a "dead time" and not be accounted for in the time allowed for any pleadings that are due subsequent to the hearing and potential oral argument.
