

 The purpose of this modification is to provide incremental funding in the amount of \$58,883.00 thereby increasing the total obligations from \$96,069.00 to \$154,952.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$154,952.00 of which \$146,500.00 represents the estimated reimbursable costs, and the amount of \$8,452.00 represents the fixed fee."

All other terms and conditions remain the same including the contract ceiling at \$154,952.00.
