The purpose of this letter is to notify the staff that additional time is required to finalize the schedule for the response to Environmental Request for Additional Information (RAI) H 4.2-1 identified in Reference 1. Reference 2 provided schedule information for this RAI which associated the response with the transmittal of the plot plan change supplement for Environmental Report (ER) Section 4.2.

RAI H 4.2-1 requested that PPL, "Provide construction reports for the cutoff wall that will surround the nuclear island and Essential Service Water Emergency Makeup Supply (ESWEMS) pumphouse." The reports requested by RAI H 4.2-1 are no longer applicable as a result of the decision to relocate the plant footprint within the existing project boundary in order to reduce wetlands impacts. PPL is currently reviewing the updated reports to determine if new environmental impacts exist. PPL will provide the schedule for transmitting the H 4.2-1 response by February 28, 2011.

This letter creates a new commitment to submit the H 4.2-1 schedule by February 28, 2011.
