SUBJECT: SOUTH TEXAS PROJECT UNITS 3 AND 4, COMBINED LICENSE  
APPLICATION – ADVANCED SAFETY EVALUATION FOR  
CHAPTER 4, “REACTOR”

By letter dated September 20, 2007, STP Nuclear Operating Company (STPNOC) submitted an application to the U. S. Nuclear Regulatory Commission (NRC) for a combined license (COL) application for South Texas Project (STP) Units 3 and 4.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Safety Evaluation (SE) with No Open Items for Chapter 4, “Reactor.” (ML110340401). Unless otherwise stated in the SE, the staff’s review was based on Revision 4 of the application. The SE is being provided to support a meeting of the subcommittee of the ACRS scheduled for March 8, 2011. The ACRS Full Committee meeting will be held after the subcommittee meeting.

The staff has reviewed the safety evaluation and found no topics that meet the categories of interest that ACRS members would like to review in detail.

Therefore, the staff requests that the ACRS withhold the SE from public disclosure until the information has been released publicly in ADAMS.

The staff will inform the ACRS immediately if STP requests that any of the information in the SE be withheld from public disclosure.
