QUANTITY OF REMOVABLE CONTAMINATION

Dear Ms. Begnoche:

This letter acknowledges receipt of your letter dated November 19, 2010, to the U.S. Nuclear Regulatory Commission (NRC), regarding your report of a leak test of a nickel-63 source with greater than 0.005 microcuries of removable contamination.

As you discussed with Mr. Aaron McCraw, of my staff, during a January 26, 2011, follow-up telephone call, you discovered the reportable quantity of removable contamination during a routine leak test of a nickel-63 source in a Varian Instruments gas chromatograph. You indicated that the source and device were bagged and isolated at your facility and are inaccessible to personnel. You also indicated your intent to dispose of the source and device, as well as other similar devices that are no longer in use. We have reviewed your actions and have no further questions at this time. Our review of this event is closed.
