RE: Amending material license 53-29296-01 to additional location

Dear Mr. Whitten:

We wish to amend our material license (# 53-29296-01) to include a second location on the island of Oahu. The second address is 92-1780V Kunia Road, Kunia, HI 96759. We wish to keep the first location at the airport site.

The added location is a small portion of the former Del Monte Corporation processing and shipping facility. The site had not become available until this year.

The RSO remains to be Andrew Buchan. However, his contact number has changed to (505) 269-7462.

Pa'ina will install the same equipment as applied for in the original license application which is a Genesis II irradiator build by Gray*Star, Inc.

However, a few minor changes will be made to the facility layout and operation. Attached are the following:

1. to supplement Figure 9-C, pg. 43
2. to supplement Figure 9-B, pg. 42

Test borings have not yet been performed and the exact soil conditions have not been identified. Therefore, the method of excavation and installation of the pool has not yet been determined.

On page 28, second paragraph the original application reads:


